## A G R E E M E N T

Under the patronage of the House of Mentors, the mentor intends to participate in a competition of ideas known as „European Student Challenge“ (termed as „**competition**“). The objective is to support the participator in the competition (termed as „**mentee**“) in the role as mentor. In this context the mentor will get access to confidential information and documents of the mentee's project (termed as „**information**“, as defined further below).

Information as to this agreement encloses all non-public information of commercial, financial, technical, corporate, strategic, or any other information by nature associated with the project. It is not of interest whether the information is in written, electronic, oral form, or has been acquired through visual, or audio channels, or any other media. This includes by sample but not considered as complete: analyses, studies, sketches, lists or any other material exhibited in connection with project of the mentee.

By signing this agreement the mentor commits himself towards the House of Mentors and the mentee (by way of a contract to the benefit of third parties according to § 328 BGB) as defined in the following:

1. The mentor obliges himself to treat all entrusted information strictly confidential and to employ the information and documents exclusively within the context of the competition. The mentor assures that he will not exploit the information for any other purpose.
2. The mentor acknowledges that all copyrights, trademark rights, patent rights, community design rights or other commercial rights for the protection of the intellectual property in the context of the mentee's project remain exclusively with the mentee and that the mentor will not draw any titles related to the context of the project towards the mentee and the House of Mentors.
3. The mentor guarantees that he will not engage in the exploitation of the information acquired throughout the project for his own commercial or private interest after the end of the contest.

The entrusted or acquired information are not allowed to be made accessible to third parties or the public before the written consent and approval of the mentee, be duplicated in any way, may it be as publication, copy, extract, or abstract neither in parts nor as a whole. The mentor commits himself to protect the access to the information by third parties.
5. The obligation for strict confidentiality remains valid also in the case in which the information was demonstrably known to the mentor thereof the project or had been acquired in other ways before they had become public.
6. The mentor commits himself to hand out on demand all information and documents provided, including all copies afore named, and to destroy all additional analyses and confidential details and, in addition, to confirm in a written statement that it complies with the requirements. The return and destruction of the documents does not liberate the mentor from the ongoing safeguard of the confidentiality as defined before.
7. Alterations and additions of the agreement require the written form. This also includes the amendment of the written form requirement waiver form specifications.
8. In case of the legal ineffectiveness of the provisions determined herein both parties commit themselves to replace the relevant provision of this agreement through one of a nature that complies with or is close to the original purpose sought.
9. This agreement is subject to the law of the Federal Republic of Germany. Any legal dispute that derives from this agreement, as far as legally permissible, will be settled at the court of residence in Frankfurt/Main.
